An Act to amend the Bretton Woods Agreements Act, 1962

ENACTED by the Parliament of the United Republic of Tanzania.

- 1. This Act may be cited as the Bretton Woods Agreements (Amend-Short title ment) Act, 1978, and shall be read as one with the Bretton Woods Cap. 469 Agreements Act, 1962 (hereinafter referred to as "the principal Act").
 - 2. Section 3B of the principal Act is hereby amended—

Section 3B amended

- (a) in the marginal note, by deleting the word "account" and substituting for it the word "department"; and
- (b) by deleting the word "account" in the second line of that section and substituting for it the word "department".
- 3. The principal Act is hereby amended by inserting, immediately Section 3c inserted after section 3B, the following section:

"Acceptance of second amendment Agreement

- 3c. The acceptance by the Government of the proposed Second Amendment to the Fund Agreement is hereby approto the Fund ved, and that acceptance shall be signified by the Minister on behalf of the Government.".
- 4. Section 4A of the principal Act is hereby amended, in subsection Section 4A (2), by deleting the figure "5" which occurs after the word "section" and amended substituting for it the figure "4".
 - 5. The Schedule to the principal Act is hereby amended—

(a) by deleting section 8 of Article IX and substituting for it the following:

Section 8

Immunities and privileges of officers and employees-

All governors, executive directors, alternates, members of committees, representatives appointed under Article XII, section 3 (j), their advisors, and officers and employees of the Fund:

- (i) shall be immune from legal process with respect to acts performed by them in their official capacity except when the Fund waives this immunity;
- (ii) not being local nationals, shall be granted the same immunities from immigration restrictions, allien registration requirements, and national service obligations and the same facilities as regards exchange restrictions as are accorded by members to the representatives, officials, and employees of comparable rank of other members; and
- (iii) shall be granted the same treatment in respect of travelling facilities as is accorded by members to representatives, officials, and employees of comparable rank of other members:

Provided that, if the Fund declares, pursuant to section 1 of Article XII of the Fund Agreement, that the provisions of Schedule D shall apply, section 8 of Article IX shall apply to councillors, their alternates and associaties, and to any other person entitled to attend a meeting of the Council";

(b) in the Fund Agreement, by deleting the heading "Article XXVII (b)" and substituting for it the heading "Article XXI (b)".
