An Act to apply a further sum of three hundred eighty six million, nine hundred fifty eight thousand, six hundred twenty seven shillings out of the Consolidated Fund to the Service of the year ending on the thirtieth day of June, one thousand nine hundred eighty eight and to appropriate the supply granted.

ENACTED by the Parliament of the United Republic of Tanzania.

1.(1) This Act may be cited as the Supplementary Appropriation (For Financial Year 1987/88) (No.3) Act, 1994, and shall be read as one with the Appropriation Act, 1987

Short title and inter-pretation Acts, 1987 No.9

(2) The expressions used in this Act shall each have the meaning ascribed to it in the Exchequer and Audit Ordinance.

2. The Treasury may issue out of the Consolidated Fund and apply towards the supply granted for the service of the year ending on the thirtieth day of June, 1988, the sum of three hundred eighty six million, nine hundred fifty eight thousand, six hundred twenty seven shillings.

Issue of Shs. 386,958,627 out of the Consolidated Fund

3. The sum granted by section 2 shall be appropriated to the purposes and in the amount specified in the second, and fifth columns, of the Schedule to this Act.

Appropriation of moneys voted

4.(1) The Minister may at any time or times not later than the thirtieth day of June, 1988, borrow within or outside Tanzania or partly within and partly outside Tanzania, any sum or sums not exceeding in the whole three hundred eighty six million, nine hundred fifty eight thousand, six hundred twenty seven shillings by way of loan, advance, the issue of bill or bank overdraft and on such terms and conditions as the Minister may deem expedient, and may charge any such loan or advance on any of the assets of the United Republic (including securities forming part of the Consolidated Fund).

Power of the Minister to borrow

(2) Any money borrowed under this section shall be placed to the credit of the exchequer account and shall form part of the Consolidated Fund, and be available in any manner in which that Fund is available.

(3) Any money borrowed under this section shall be subject to repayment not later than the thirty-first day of October, 1988, and any sum required for the repayment of any money so borrowed, and of any interest payable thereon shall be charged on and paid out of the Consolidated Fund.
