2. The Office of the National Assembly now invites sealed tenders from eligible Tenderers for **Leasing Space for Provision of Canteen Services** for the **Office of the National Assembly**.

Tendering will be conducted through the **National Competitive Tendering** procedures specified in the Public Procurement (Goods, Works, Non-Consultant Service and Disposal of Public Assets by Tender) Regulations, 2013- Government Notice No. 446 of 20th December, 2013 and is open to all Tenderers as defined in the Regulations.

Interested eligible Service Provider may obtain further information from and inspect Tender Documents at the office of the Secretary of the Tender Board, Parliament Buildings, Administration Block, 2nd Floor, Room No. 222 Dar es Salaam Road, P.
