1. This is in reference to the General Procurement Notice (GPN) for this assignment which appeared in the Daily News (News Paper) of 15th August, 2018; Habari Leo (News Paper) of 15th August, 2018; the National Assembly Office and PPRA websites; (www.parliament.go.tz & www.ppra.go.tz) respectively.
2. The Government of Tanzania has set aside funds for the operation of the Office of the National Assembly during the financial year 2018/2019. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the Supply, Installation and Commission of Studio Equipment for the Office of the National Assembly (Vote 42).
3. The Office of the National Assembly now invites sealed tenders from eligible National Suppliers to Supply, Installation and Commission of Studio Equipment for the Office of the National Assembly (Vote 42) as shown in the **Schedule of Requirement and Technical Specification (Sect. VI & Sect. VIII)**.
4. Tendering will be conducted through the **National Competitive Tendering** procedures specified in the Public Procurement Regulation (Goods, Works, Non-Consultant Service and Disposal of Public Assets by Tender), 2013 – Government Notice No. 446 of 20th December, 2013 as amended 2016 and is open to all Tenderers as defined in the Regulations.
5. Interested eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of the National Assembly Tender Board Secretary, Parliament Buildings, Administration Block, 2nd Floor, Room No. 222 Dar es Salaam Road P. O. Box 941 DODOMA from 7.30 am to 3.30 pm on Mondays to Friday inclusive except on public holidays.

6. A complete set of Tendering Document(s) in **English language** may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of **TZS. 100,000.00**. Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to Clerk of National Assembly, **Account No. 9921144201**, P. O. Box 941, Dodoma.
7. All Tenders must be accompanied by a **Tender Securing Declaration** in an acceptable format.
8. All tenders in one (1) original plus two (2) copies, properly filled in, and enclosed in plain envelopes marked "**Tender No. IE.006/2018-19/HQ/NC/10 for Supply, Installation and Commission of Studio Equipment for the Office of the National Assembly (Vote 42)**" must be delivered to the Secretary of the Tender Board, Parliament Buildings, Administration Block, 2nd Floor, Room No. 222 Dar es Salaam Road P. O. Box 941 DODOMA at or before **14:00 Hours Local Time on Tuesday 2nd April, 2019**. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening ceremony at the Conference Room No. 227, Parliament Buildings, Administration Block, Dar es Salaam Road, Dodoma Municipality.
9. Late Tenders, Portion of Tenders, Electronic Tenders, Tenders not received, Tenders not opened and not read out in public at the tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
10. The Office of the National Assembly Tender Board is not bound to accept the lowest or any tender.
